The applicant has 1 publication, which shows the ability to produce high-quality scientific data. I am a bit confused at the proposed research. It is not entirely clear that the applicant has a good feel for the proposed project as the proposal jumps between topics and with very little detail. Some of the experiments don't seem terribly realistic. Overall, the project seems overly ambitious and, most importantly, the proposal could benefit greatly from a well-defined hypothesis.
